NOTIFICATION

Clause (a) of sub rule (1) of rule 14 of Gurugram Metropolitan Development Authority Rules, 2018 requires one member of the Residents Advisory Council to be nominated from amongst the Presidents of eligible residents Associations to represent residents in sectors originally developed by the Haryana Urban Development Authority, now Haryana Shehri Vikas Pradhikran, whether transferred to the Municipal Corporation, Gurugram or not. Only one application was received in response to the public notice issued by inviting eligible Residents Welfare Associations under the said clause.

2. The eligibility of the applicant was ascertained by a committee constituted in GMDA. The applicant Residents Welfare Association namely Kendriya Vihar Apartment Owners Welfare Association was found to have met the prescribed eligibility criteria. No draw of lots was required as only one residents Association had submitted its application in response to the public notice.

3. As required under sub rule (4) of rule 14 of the said Rules, the nomination proposed to be made was placed on the website of GMDA for submitting any petition by any resident of the notified area against the nomination along with specific reasons. No petition was received within the specified period of 30 days against the proposed nomination.

4. Accordingly, in exercise of the powers available under sub rule (2) of rule 14 of the said Rules, I, V. Umashankar, Chief Executive Officer, GMDA nominate, Sh. Abhey Raj Singh, President, Kendriya Vihar Apartment Owners Association as member of the Residents Advisory Council in fulfilment of the provisions of clause (a) of sub rule (1) of rule 14 of the said Rules. Sh. Abhey Raj Singh, President, Kendriya Vihar Apartment Owners Association will represent residents Association under clause (g) of sub section (2) of Section 11 of the GMDA Act, 2017 read with clause (a) of sub rule (1) of Rule 14 of the said Rules.

5. The term of Sh. Abhey Raj Singh as Member of the Residents Advisory Council shall be governed by rule 21 read with rule 22 and rule 23 of the GMDA Rules, 2018.
